What are Prosure360's international capabilities?

What sets us apart from the crowd is our ability to cater to clients based in and outside the EU. We can create question sets applicable to specific countries, supporting clients and service providers that operate internationally.

In Prosure360, we use a red flag alert system, giving your suppliers a risk score of gold, silver, or bronze. Gold suppliers are extremely low risk, meaning they are reliable and qualified. On the other end of the spectrum, amber suppliers are relatively high risk and may not be the best fit for your business. This allows you to see your service providers' financial health and status. This empowers you to make an educated choice about whether to work with them or not.

Prosure360 also provides SSIP assessments, which we've now extended to include Republic of Ireland Duty Holder Categories, including:

- SSIP Approved IE.
- SSIP Approved IE Contractor.
- SSIP Approved IE Project Supervisor Construction Stage (PSCS).

This means that our clients who have operations in Ireland can have specific SSIP for that operational base, giving them clear visibility between UK and Ireland based service providers. It also means that businesses who are solely based in Ireland can use Prosure360; this will support clients in building their relationships with service providers as they can choose which SSIP certification is best suited to their organisation.



Why does this matter to our clients?

For our clients, we act as a single source of truth for all UK and non-UK service providers, suppliers, and contractors. This removes the need for multiple software solutions because Prosure360 allows you to log in to one system no matter what country you are operating in. Ultimately, all UK and non-UK clients can access the Prosure360 platform to manage suppliers, contractors, and service providers.

With the ability to create bespoke questions, Prosure360 can build question sets that are applicable to the country you are operating in.
